Dear Interfraternal Friend,
I am excited to share with you the news that a number of outstanding individuals nationwide have started the Fraternity & Sorority Political Action Committee (PAC). These men and women have all been leaders inside their own fraternal organizations and share a common passion for doing all they can to ensure fraternities continue to be a vibrant presence on college campuses. Many of these leaders have been actively involved in interfraternal efforts to engage Washington policymakers on a range of policy issues that influence fraternity life, such as: (1) reforming federal tax laws to encourage charitable contributions to sustain not-for-profit student housing, (2) improving student safety and housing, (3) fighting hazing and substance abuse on campus, (4) protecting a student's First Amendment right to join a fraternal organization on campus, and (5) educating Congress and the executive branch about the key role fraternities and sororities play in developing future generations of American leaders.

Fraternity membership can play a key role in developing college students into outstanding leaders for America's future and is an outstanding vehicle for committed alumni members to help others achieve their dreams. We benefited from our own memberships in these organizations and we continue to work to see that future students have similar opportunities to use fraternity life to become better citizens, students and leaders on our campuses and in our communities.

These efforts led us to the conclusion that we need to work together to support federal candidates who recognize the value of fraternity life and will support a policy agenda that improves the experience we offer to our student members. Thus, the creation of Fraternity and Sorority PAC in March 2005. The PAC's primary goal is to support the approximately 160 men and women who are fraternity and sorority alumni

in the United States House and Senate who help preserve and improve the fraternal experience. In addition, the PAC will be supporting other members of the House and Senate who support policy objectives that preserve and improve the fraternal experience.

The PAC's goal is to raise \$500,000 for this election cycle (2005-06), with most of that money coming in before July 1, 2006. To date, we have raised more than \$165,000 in our first six months, which is more than one-third of our goal for the entire two-year cycle. We are already the largest higher education-focused PAC in existence. To give you a sense of our early success, the PAC is already bigger than the PACs for such well-known entities as Yahoo, Amazon, Tyson Foods, and the American Society of Association Executives.

The PAC's success comes from a strong group of leaders who serve on our Board of Directors and the Finance Committee. I can't say enough about the great work these people are doing for the Greek world by taking a leadership role in the formation of

THE PAC'S STATUS TO DATE

The PAC has raised more than \$165,000 in our first six months of operation.

We are already more than one-third of the way to our cycle goal of \$500,000.

The PAC has received contributions ranging from \$20 to \$10,000 (married couple giving jointly).

The PAC has more than 275 contributors from 38 states.

We have received contributions from members of at least 45 different fraternities and sororities.

We are already the largest higher education-focused PAC in the nation.

The Fraternity and Sorority PAC held a fundraiser on April 18 in Washington, D.C., to formally announce its formation, mission, and fundraising goals. The event was attended by more than 250 Greek student and alumni leaders from across the nation, as well as several special Congressional honorary event co-chairmen. All of the Congressional guests offered inspiring remarks about the importance of Greek life in shaping the values of future generations of American leaders. Senator **Mike Enzi** (R-WY/Sigma Chi) discussed the important role fraternities play in higher education and his own leadership experiences as an undergraduate. Congressman **Pete Sessions** (R-TX/Pi Kappa Alpha) and Congresswoman **Stephanie Tubbs Jones** (D-OH/Delta Sigma Theta) spoke with passion about their joint efforts as co-chairmen of the Congressional Fraternal Caucus in advancing federal legislation that helps preserve and sustain fraternity life. Congresswoman **Marsha Blackburn** (R-TN/Chi Omega) highlighted the important role Greek life has in developing women as outstanding leaders. LEGISLATIVE ITEMS OF INTEREST TO THE GREEK WORLD

Fraternity and Sorority PAC is concerned with a number of issues. In each issue of the donor newsletter, we will try and update you on the status of one or two legislative items of interest to the Greek world.

Higher Education Reauthorization Act

Greeks are monitoring the pending reauthorization of the nation's federal higher education laws. We are working to ensure that the new package includes protections for college students to exercise their first amendment rights to join fraternal organizations.

College Fire Prevention Act (H.R. 128)

Greeks are working with Congresswoman Stephanie Tubbs Jones and a bipartisan group of 92 other sponsors in the House to pass this bill, which would provide federal matching grants for existing fraternity housing to install critical life safety equipment.

Collegiate Housing and Infrastructure Act of 2005

Greeks nationwide are trying to pass the Collegiate Housing and Infrastructure Act of 2005, which would essentially allow for charitable contributions made to fraternity and sorority educational foundations [501(c)(3) organizations] to be used to improve existing housing or build new fraternity housing. This important legislation will allow fraternities and sororities nationwide to improve the condition of their housing for student members, with a strong focus on increasing the safety measures available.

As of August 1, the House version of this bill, H.R. 1548, has 57 sponsors; the Senate version of the bill, S.713, has 12 sponsors. Sponsors in the House and Senate include:

Learning More About Giving to The Fraternity & Sorority PAC

- ◆ Under current law, an individual may give the PAC up to \$5,000 per calendar year.
- ◆ The PAC may in turn give up to \$5,000 to an individual candidate per election cycle.
- ◆ Contributions to the PAC are not tax-deductible and may not be reimbursed by your employer or anyone else.
- ◆ Only individuals and other PACs can contribute to Fraternity & Sorority PAC – corporations and associations CANNOT make contributions to the PAC.
- ◆ As part of our \$500,000 overall goal, we have three sub-goals:
 - At least 50 \$5,000 Donors (legal max per individual per year) - \$250,000
 - At least 200 \$1,000 donors - \$200,000
 - At least 500 donors at \$100 or more - \$50,000
- ◆ We will have several donor recognition levels that include:
 - \$5,000+ - Founders Society
 - \$2,500 - \$4,999 – Charter Member
 - \$1,000-\$2,499 – Legacy Member
 - \$500-\$999 – Honorary Officer
 - \$250-\$499 – Leader
- ◆ The PAC is bipartisan and will give to candidates of both parties.
- ◆ You can only participate in the PAC as an individual.
- ◆ All fraternal organizations are prohibited from endorsing, campaigning or

advocating for or against political candidates, but individuals are free to provide as much support as they wish to the PAC.

How the PAC Evaluates Candidates for Support:

- ◆ Specific policy issues that the PAC is currently using to evaluate candidates may include (but not be limited to):
 - Support of changes to the federal tax code that promote charitable giving or create parity between the tax status of charitable contributions made to benefit fraternity members and other students.
 - Support of passage of the Collegiate Housing and Infrastructure Act (H.R. 1548/S.713), which would allow charitable contributions to be used to make critical infrastructure improvements to existing fraternity housing and construct new fraternity housing.
 - Support of freedom of association rights for students to join fraternal organizations while in colleges and universities.
 - Support of initiatives to improve student housing and safety on college campuses.
 - Support of initiatives to eradicate hazing and other mistreatment of college students.
 - Support of initiatives to improve funding for student loans and other financial aid options.
 - Maintain the existing Title IX exclusion for college fraternities and sororities, which allows both men and women to have outstanding leadership experiences.
