PAC Closes In on \$1 Million Goal for First Six Years

With Only \$178,502 Needed, Your Help Is Crucial

The PAC continues its efforts to support fraternity and sorority member candidates and friends, to fundraise, and to engage alumni. In this newsletter you will see how the various organizational representatives fare in our rankings. It is very important, now more than ever, to support the PAC because we want to help the many fraternity and sorority members who are running for political office. Given the climate in Washington, D.C., I am sure you will agree that we need to provide assistance to our friends and help them carry our message to other lawmakers.

We hope to see some movement on the Collegiate Housing and Infrastructure Act (CHIA) in early 2010 as Congress increasingly turns its attention to comprehensive tax reform issues. As of November 30, we have 173 House sponsors and 24 Senate sponsors of CHIA, and we add new sponsors regularly. As you can imagine, with Congress focusing much of its 2009 attention on the critical issue of healthcare reform, there has been little time to address other tax issues, but we expect that situation to change in 2010 and we are well positioned to be added to major tax legislation in the new year. Your continued engagement with your Senators and Representatives is crucial in 2010 if we want to pass this groundbreaking legislation. We have also been active in working to pass the College Fire Protection Act during this Congress, which would provide matching grants for critical life-safety improvements to all forms of student housing, including our own.

The PAC has held two very successful events, one in Atlanta on August 25 and one in Dallas on November 9. Again, there are related articles, as well as testimonials from donors and from members of Congress about Greek life.

I want to thank you for your efforts to help the PAC reach our goal of \$1 million in donations within six years of operation. While we are steadily moving toward that figure, it is an aggressive goal given the current state of the economy. Your support is essential in our efforts to pass the CHIA. If you are a donor or have made a pledge to con-

tribute, I want to thank you profusely for your support. If you have an outstanding pledge, I ask that you make your payment as soon as you can. If you are a former donor or have not yet made a contribution to the PAC, I urge you to make a gift to this 2009-10 cycle. No gift is too small to support our efforts. For your convenience, you may use the enclosed pledge form and reply envelope.

Remember the PAC's annual dinner will be held April 20 in Washington, D.C. Seats are \$500 a piece. I hope to see many of you there.

DALLAS-AREA PAC EVENT

Impact Felt in D.C. as PAC Keeps Greek Issues in Front of Policymakers

More than 75 people, including several colleagues, representing more than 20 Greek organizations attended the PAC Dallas-area reception on November 9. The keynote speaker was Congressman Pete Sessions (R-TX/PIKA). Congressman Sessions, a lead sponsor for the Collegiate Housing and Infrastructure Act in the House and co-chairman of the Congressional Fraternal Caucus, remarked that we are gaining support for Greek-related issues. He encouraged everyone to continue supporting our initiatives, especially the CHIA, and to not become discouraged by Congressional delays. Congressman Sessions talked about the core lessons Congressional Greeks have learned from their fraternal experience and how that guides their daily lives as American leaders. The Congressman praised the PAC for keeping Greek issues in front of policymakers and for supporting Greeks who run for office. He made it clear that the PAC's impact is felt in Washington.

Other area dignitaries in attendance were former Dallas City Council member Gary Griffith, ΣΦΕ, and Texas Railroad Commissioner Michael Williams, ΣΦΕ. Mr. Williams is regarded as a front-runner to be appointed to the Senate seat that Kay Bailey Hutchison may vacate in the near future.

Additionally, two interfraternal national presidents were in attendance: Mike Duncan, knight

commander of Kappa Alpha Order, and Wayne Tucker, grand consul of Sigma Chi.

PAC President Larry Wiese, KA Order, and immediate Past-President Kevin O'Neill, ΔΧΑ, provided updates of the PAC activities. They reported that in 2009 the PAC has almost 700 donors from more than 50 Greek organizations.

Larry and Kevin noted that one of the reasons for the wide support is that the PAC is truly bipartisan. Contributions have been made to

the major political parties at a rate of 52% to Republicans and 48% to Democrats. They thanked the donors for their contributions, which allow the PAC to provide critical support to Greeks running for House and Senate. The PAC anticipates supporting several Greeks trying to get elected for the first time in 2010.

Many thanks to the other PAC leaders who attended, including Vicki Nixon, ΔΓ, Ryan Brennan ΣΦΕ, Donna Cherek, ΑΧΩ, and James Owens, ΣΝ.

For those who live in the Dallas area, plans are already underway for the 2010 PAC event.

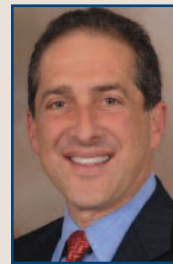

Congressmen Who Support the PAC

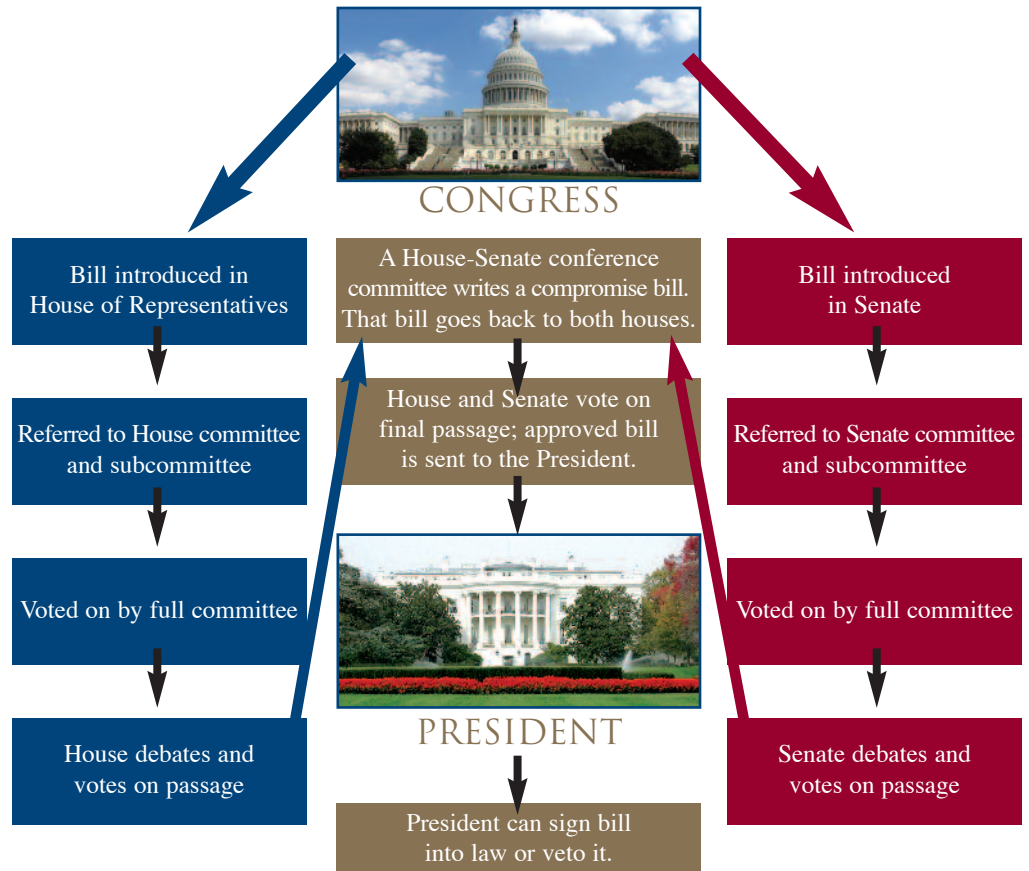
The PAC has many loyal Congressional supporters. Below are just two of the many who attended the April 2009 PAC dinner and who back our initiatives.
